## CFO Range Inspection Summary – HPRC May 17, 2023

I wanted to reach out to give our members an update on our recent CFO Inspection.

A CFO full Range Inspection was completed this year for both our indoor and outdoor ranges.

In summary, we passed our inspection with flying colors!

I would like to thank those members who have/continue to help us maintain the high standards of safety here at HPRC.

A quick summary of the CFO visit is outlined below.

## **INDOOR RANGE**

The CFO was very complimentary of our Club. Since our last inspection the Club has done many new things to enhance and maintain our overall safety and compliance.

As part of the new CFO requirements added this year, moving forward all ranges are required to now maintain a Protected Zone (also referred to as a Cone of Fire).

The Cone of Fire is measured by way of a 15-degree lateral/horizontal angle from the shooting stall to the outside walls forward.

This Cone of Fire area requires that no hard obstacles, props, or other wall mounted items within the Cone of Fire) that may accidentally cause a ricochet. Signage does not apply.

Working with the CFO the necessary items to move have been identified and will take place over the next 30 days.

The impact of this update at this time will primarily impact some of the storage props for the Action League. The Action League has already started on this task.

The Club will also invest in/update signage to clearly identify the Cone of Fire area (this is not required by the CFO) within the next 30 days as well.



## **Protected Zone Details**

10.2. PROTECTED ZONE To ensure the containment of bullets fired in accordance with <u>Section 14. Sance Operation</u> Instructions with the bulleting, all indoor ranges shall have a downrange Protected Zone (PZ). This area surrounds the bullet trap and a significant portion of the downrange area. The Safety Committee has also made a recommendation to augment the First-Aid kit in the outdoor range with a Trauma Kit such that we have the same setup in both ranges. The updated kit is secured and will be in place when the range opens next month.
